I now have the following questions regarding the specific information provided for Polling Station 074. A photocopy of the specific information provided to me on Poll 074 is enclosed for your convenience. Poll 074 was listed as Mobile Poll # 3. This poll has a vote total of 81 according to the unofficial poll results on the Elections Alberta website. My questions are:

1. Why did the Poll Clerk fail to sign the poll book?
2. Why did the Deputy Returning Officer fail to sign the poll book?
3. Why did the Poll Clerk fail to swear or affirm an oath after closing the poll?
4. Why did the Deputy Returning Officer fail to swear or affirm an oath after closing the poll?
5. Who was the Poll Clerk at Poll 074?
6. Who was the Deputy Returning Officer at Poll 074?
7. The total number of ballots issued according to the list provided is 83. Why does this number not match that on the Elections Alberta website?
8. Were the voters listed in the poll book sworn of affirmed prior to receiving their ballots?
9. Was the information in this poll book used to determine the final vote count?
10. Why did the Returning Officer for Edmonton-Gold Bar accept this poll book?
11. Why did the Returning Officer fail to sign the poll book?
12. How many hours was Mobile Poll #3 open at each location?
